SB 1387 UNDERMINES LOCAL AUTHORITY AND JEOPARDIZES COST-EFFECTIVE AIR QUALITY PROGRAMS VOTE NO ON SB 1387

UNDERMINES LOCAL AUTHORITY OF STATE'S LARGEST REGIONAL AIR DISTRICT

Gives Sacramento leaders control of more than one-third of the appointed seats on the South Coast Air Quality Management District Board, shifting local control over critical regional air quality planning from duly elected city and county representatives to state lawmakers. SCAQMD Board Members should be accountable to their electorate, not Sacramento Leadership.
